Dalrada Precision has secured contracts with new and existing suppliers/OEM customers totaling \$1,400,000 with proposals submitted for additional revenues. The awarded business is currently in production at our Malaysian and other third-party facilities, and we are actively shipping as parts are produced.

Our sales pipeline is expanding due to our continuous success of procuring additional certified component parts. In addition, our existing customers are rolling in more of our new parts into their production plans.

Our current customer base include the largest manufacturers and suppliers within the semiconductor, PC / laptops / tablets /datacenters, cybersecurity, network systems, and fitness equipment industries.

Typical orders include parts ranging from ball bearings, spacers, brackets to drive carriers with quantities as small as 50 units and up to 100k units.

We anticipate a promising future for our parts business as our Malaysian facility and equipment are now operating efficiently with processes in place to produce with the cost, speed, and quality our customers expect.

Extraction machine for pharmaceutical-grade nutraceutical extracts (CBD growers and manufacturers being a primary target along with pharmaceutical and healthcare companies).

A disruptive and novel machine that based on the current architecture and design, will produce 10 times the current output (active ingredient) of any other extraction machine on the market. The project is well underway with the simulation design, plant specifications, and ordering of parts to be completed by March 2020, and construction of the first machine completed and ready to be shipped by End of 2020.

Dalrada Precision, in conjunction with third-party brokers within the CBD industry, have begun the sales and marketing process to promote the pre-ordering of the machines to interested customers. Based on extensive research and networking, we have identified various parties that have reviewed initial designs and concepts and are willing to place down payments to reserve their machine.

Dalrada Health is in the process of filing a patent application (India and US) for a revolutionary Visual Inspection with Acetic Acid (VIA) kit to detect cervical cancer at a precancerous stage, allowing for effective treatment. According to the World Health Organization (WHO), 85% of cervical cancer deaths occur in low-and middle-income countries, such as India. The approach and methodology is very much needed in resource- constrained geographies where access to screening common cancers and follow-up is a challenge. Cervical cancer takes the lives of eight women in India every hour.

Dalrada, along with its Chief Medical Officer, Dr. Payal Keswarpu, have established ongoing communications with key Indian health stakeholders and entities to progress the development of the VIA kits.

Clinical studies conducted tests on 75 patients using the product with feedback from Gynecologists and practitioners on the configuration and use of the kits. Results collected to date aligns with the standard form of screening tests in the market.

The product encompasses the easy-to-use kit, along with technology-enabled AI-driven imaging capabilities that guides instant results and informs population health.
